On January 3, 2025, the State of Idaho filed a Petition pursuant to Idaho Code § 42-1406D for the commencement of a general adjudication *inter se* of all rights arising under state or federal law to the use of surface and ground water for the Kootenai River basin water system and for the administration of such rights. A commencement hearing on the Petition is presently set for April 15, 2025. Additionally, the Court via Order dated January 9, 2025, set a deadline of March 28, 2025, for notices of appearance, prehearing statements, and briefs or memorandums in support of any legal arguments to be presented with respect to the Petition.

On March 26, 2025, the United States and the State of Idaho filed a Joint Motion requesting a 90-day extension to file pre-hearing statements and briefs or memorandums in support of any legal arguments with respect to the Petition. They further request the April 15, 2025, hearing be vacated and reset at least 14 days after the deadline for the filing of pre-hearing statements, briefs, or memorandums. The Court in an exercise of its discretion will grant the Joint Motion on the basis it is unopposed.

THEREFORE, BASED ON THE FOREGOING THE FOLLOWING ARE HEREBY ORDERED:

- 1. The deadline for the filing of notices of appearance, prehearing statements, briefs, or memorandums in support of any legal arguments to be presented with respect to the Petition is extended to June 26, 2025.
- 2. The commencement hearing on the Petition previously set for April 15, 2025, is hereby vacated.
- 3. The commencement hearing on the Petition is reset for July 15, 2025, at 1:30 p.m. (Pacific Time) at the Snake River Basin Adjudication Courthouse, 253 3rd Avenue North, Twin Falls, Idaho. This hearing will be conducted using the ZOOM remote hearing application. Instructions for Zoom are attached to this Order.
